These amendments clarify that the operator of record for a company must hold a certificate equal to the classification designated by the Ohio

Environmental Protection Agency (Ohio EPA) or obtain authorization from the director of the Ohio EPA, and that the potable water furnished by the companies complies with the federal and state requirements for drinking water. Further, the amendments provide that the amount of unaccounted-for water be based on a rolling twelve-month average of metered and production quantities, and requires that tank draining, street cleaning, and sewer flushing be excluded from unaccounted-for water. The amendment also allows the companies to provide notifications to the Commission either via hard copy or electronically.
