This rule sets forth the disconnection procedures. The amendments require 14 days notice before disconnection if the company is denied access to the customer premises for the purpose of reading, replacement, or maintenance of the meter, and they require that the contact information for both the Commission and the Office of

the Ohio Consumers' Counsel be included on disconnect notices. Further, the amendments set forth the process that must be followed on the day of disconnection. With regard to medical certifications, the amendments require that, if service has been disconnected within 21 days prior to certification, service be restored, and provides that certification may also be obtained through a physician assistant, clinical nurse specialist, certified nurse practitioner, and certified midwife.
