This rule establishes the lifeline requirements for an ILEC that is an eligible telecommunications carrier (ETC) (ILEC ETC) under 47 C.F.R. 54.201. This rule has been amended to add an incorporation by reference comment box, eliminate programs from the list of program-eligible assistance programs to mirror federal requirements, and to add provisions for de-enrollment under certain circumstances.
