This rule sets forth the requirements for ensuring TANF eligibility of the Kinship Caregiver Program (KCP) assistance groups; the protections for ensuring that benefits and services remain TANF non-assistance; the elements of stabilization caregiving services; and defines the assistance group composition for each service. The rule is being updated to reflect section 307.81 of the Amended Substitute House Bill 110 of the 134th General Assembly (effective 6/30/2021) as the authorizing statute.
