Section 307.100 of Substitute House Bill 166 of the 133rd General Assembly creates the kinship caregiver program and permits the Ohio Department of Job and Family Services to adopt rules necessary to carry out the purpose of the program.

The rule describes the kinship caregiver program to assist kinship caregivers with providing and maintaining a home for a child in place of a child's parents by providing reasonable and necessary relief of child caring functions through family stabilization and caregiving services.
