Updating rule to align with federal guidance pursuant to the 2008 TANF Data Report.

The rule describes the federal work participation requirements and activities for work eligible individuals. The Office of Family Assistance (OFA) proposes to amend paragraph (F) of this rule to align with federal guidance for converting weekly-to-monthly hours. Although the required number of weekly hours has not changed,

converting weekly hours to monthly hours using a factor of 4.33 instead of 4.3, as designated in paragraph (I) of rule 5101:1-3-12, increases the monthly hours.
