The changes to the rule include: paragraph (C)(1) was updated to include that when a two-parent assistance group is deemed to include a child when the only minor child is in receipt of the Kinship Support program (KSP); paragraph (D)(5) was updated to include that an all-family assistance group includes two-parent assistance groups when the only minor child is in receipt of KSP; and minor language changes to improve clarity.
