The changes to the rule include updating paragraph (C)(1) to include that a two-parent assistance group is deemed to have a minor child in the home when that child is in receipt of federal or state KGAP payments; and paragraph (D)(5) has been updated to include that an all family assistance group is deemed to have a minor child in the home when that child is in receipt of federal or state KGAP payments.
