The Adult Protective Services Definition rule is being proposed for amendment as a result of the five year rule review.

This rule outlines the Adult Protective Services definitions.

Changes included adding four definitions to the rule. The first definition "Peace Officer" was added in paragraph (P) to coincide with the definition in ORC 5101.60. The three remaining definitions are new and were added for clarification. Those definitions include: "Referral" in paragraph (T), "Report" in paragraph (U) and "Screening" in paragraph (V). The definition of "Adult" was amended to remove the reference to ORC Chapter 3724, as it has been repealed. Reference to ORC Chapter 3722 was removed and replaced with its new number 5119.70 to include the revised language of an "Independent Living Arrangement." Grammatical changes were also made to the rule.
