The rule revision is a product of the collaborative partnership between ODJFS and county PCSAs. The presenting rule revisions were developed through the

Monitoring/SACWIS/Administration Rule Review Team and approved by the Partners for Ohio's Families PFOF) Rule Advisory Board. This rule outlines the public children services agencies (PCSA) requirement to participate in the child protection oversight and evaluation (CPOE) process conducted by the Ohio department of job and family services (ODJFS). Language has been added for clarity to outline the process by which a PCSA may clarify or dispute a CPOE report finding.
