This rule is being proposed to align the state cycle for monitoring public children services agencies with the federal cycle for monitoring. It is replacing rule 5101:2-57-02 which is being rescinded under section 111.15 of the Revised Code.

This rule specifies the procedures and time frames for monitoring the public children services agencies. It is replacing rule 5101:2-57-02 that is being rescinded under separate cover. The new rule changes the time frame for the monitoring cycle from eighteen to twenty-four months.
