This rule will be replacing rule 5101:2-34-38 for PCSAs that are implementing the Comprehensive Assessment and Planning Model - Interim Solution. It is substantially the same as the rule it is replacing. Additional persons and entities have been identified for the purpose of instructing the PCSA to whom the PCSA may release information. More specificity has also been added to clarify the type of information a public children services agency may not release.
