This rule sets forth the public children services agencies (PCSA) requirements regarding joint planning and sharing of information with the county departments of job and family services (CDJFS) to coordinate services to children and families. The rule was revised to include language previously captured within the case record rule to require PCSAs to request a copy of the Ohio works first (OWF) self-sufficiency contract from the CDJFS if joint planning or sharing of child welfare information occurs between the PCSA and CDJFS. Rule language was also revised to reflect the current legislative service commission standard.
