This rule is being filed to obsolete the JFS 01825 form outlined in this rule and to establish E-Track as the central depository for all training records of PCSA caseworkers.

This rule will no longer require public children service agencies to maintain the training records of caseworkers using the JFS 01825 form. All training records for caseworkers will be a portion of the data of the learning management system for the Ohio Child Welfare Training Program (currently known as E-Track). This rule outlines the training requirements for all caseworkers who provide direct service to children and families working with a public children services agency in Ohio.

Agencies will also notify the Ohio Child Welfare Training Program (Using the E-Track person add/edit web form) within thirty days of new caseworkers and assessors hired by an agency to establish an E-Track training history record for the employee.
