The rule has been amended to require a minimum of twelve hours of domestic violence training within twenty-four months of the effective date of this rule or the effective date of hire, whichever is later. It has also been amended to clarify the in-service training requirements.

The amplification for this rule also changed from 5153.76 to 5153.126 as a result of S.B. 238.
