This rule provides guidance to agencies regarding access, use, and training on the confidential information contained within the SACWIS system. Changes are being made to allow direct SACWIS access to workers who are contracted as Wendy's Wonderful Kids (WWK) recruiters for an entity other than the agency that employs them. Paragraph (B) was added to clarify when data may be accessed in the SACWIS system. Paragraph (I)(13) was revised to correct the name of the National Child Abuse and Neglect Data System. Paragraph (N) was added to allow staff who are employed as WWK recruiters for agencies other than the custodial agency to have direct access to the SACWIS system.
