This rule sets forth the procedures for conducting an intra-familial child abuse and/or neglect assessment/investigation. This rule will be replacing rule 5101:2-34-32 for PCSAs that are implementing the Comprehensive Assessment and Planning Model - Interim Solution. In addition to the requirements contained in the rule being replaced, this rule contains new requirements related to the interview of the alleged child victim without parental consent. Also, this rule specifies when the agency may request the assistance of law enforcement. Language incorporating the use of the Comprehensive Assessment and Planning Model - Interim Solution tools has been incorporated throughout this rule.
