This rule sets forth the requirements for involving a third party in the assessment/investigation of child abuse and/or neglect for the child protection program. This rule is being amended to include language permitting public children services agencies (PCSA)to use an in-house assessment/investigation unit when the report does not involve a PCSA employee or allege a criminal offense. The in-house unit must work independently of all other units within the PCSA. The PCSA must have written internal policies and procedures for the review and approval of the in-house unit's assessments/investigations.
