This rule has been amended to provide clarity to public children services agencies (PCSA) charged with the child protective services function. The rule revision is a product of the collaborative partnership between Ohio Department Job and Family Services and county Public Children Services Agencies. The presenting rule revisions were developed through the Child Protective Services Rule Review Team

and approved by the Partnership For Ohio's Family Rule Coordination Board.

OAC rule 5101:2-36-08 entitled PCSA requirements for involving a third party in the assessment/investigation of a child abuse or neglect report addresses when a PCSA shall involve a third party in the assessment/investigation of child abuse or neglect. Criteria identifying conflicts of interest have been clarified and incorporated into this rule. Additional procedures have been clarified regarding who may serve as a third party, third party involvement, third party notifications, and leading assessment/investigations. Grammatical changes, restructuring the order of paragraphs, and revisions to requirements for consistent understanding have occurred throughout the rule.
