## 5101:2-36-10 **PCSA requirements for responding to family in need of** services reports and information and/or referral intakes.

- (A) A public children services agency (PCSA) shall provide services to a child and family for the following screened in "Family In need of Services" reports:
  - (1) "Adoption Subsidy" report.
  - (2) "Child Fatality, Non-Child Abuse/Neglect" report.
  - (3) "Courtesy Supervision" report.
  - (4) "Deserted Child" report.
  - (5) "Emancipated Youth" report.
  - (6) "Home Evaluation/Visitation Assessment" report.
  - (7) "Permanent Surrender" report.
  - (8) "Post Finalization Adoption Services" report.
  - (9) "Postnatal Placement Services to an Infant of an Incarcerated Mother" report.
  - (10) "Preventive Services" report.
  - (11) "Required non-lead PCSA Interview" report.
  - (12) "Stranger Danger Investigation".
  - (13) "Unruly/Delinquent" report.
  - (14) "Interstate Compact for the Placement of Children" (ICPC).
- (A)(B) When the <u>The PCSA shall follow the procedures and provide the services</u> <u>identified for each family in need of services subcategory as follows</u> <del>public children</del> <del>services agency (PCSA) screens in a family in need of services report, the PCSA</del> <del>shall provide services to the child, family, or the child and family as specified in</del> <del>this paragraph</del>:
  - (1) For an adoption Adoption subsidy only report, services shall be provided pursuant to Chapter 5101:2-49 of the Administrative Code.
  - (2) For a child <u>Child</u> fatality, non-child abuse/neglect report, the PCSA shall follow the procedures specified in <u>pursuant to</u> rule 5101:2-42-89 of the Administrative Code.

- (3) For a courtesy Courtesy supervision report, the PCSA shall follow the procedures as specified in rule 5101:2-42-20 of the Administrative Code and sections 5103.20 5103.20 and 2151.56 of the Revised Code or as defined in rule 5101:2-1-01.1 of the Administrative Code.
- (4) For a deserted <u>Deserted</u> child report, also known as "safe haven," the PCSA shall follow procedures as specified in rules 5101:2-36-06 and 5101:2-42-04 of the Administrative Code.
- (5) For an emancipated <u>Emancipated</u> youth report, the <u>PCSA</u> shall follow procedures specified in <u>pursuant to</u> rule 5101:2-42-19.2 of the Administrative Code.
- (6) For a home <u>Home</u> evaluation/visitation assessment report, the PCSA shall follow the procedures specified in <u>pursuant to</u> rule 5101:2-42-18 of the Administrative Code or as defined in rule 5101:2-1-01.1 of the Administrative Code.
- (7) For a permanent <u>Permanent</u> surrender report, the PCSA shall follow procedures outlined in <u>pursuant to</u> rule 5101:2-42-09 of the Administrative Code.
- (8) For a post Post finalization adoption services report, as defined in rule 5101:2-1-01 of the Administrative Code. the The PCSA shall provide or arrange services to support, maintain, and assist an adopted child, adoptive family, or birth parent anytime after finalization of an adoption as specified in rule 5101:2-1-01 of the Administrative Code.
- (9) For a postnatal Postnatal placement services to an infant of an incarcerated mother report, the PCSA shall follow the procedures specified in pursuant to rule 5101:2-42-60 of the Administrative Code.
- (10) For a preventive Preventive services report, as defined in rule 5101:2-1-01.1 of the Administrative Code. the The PCSA shall provide services aimed at promoting awareness or preventing child abuse and neglect which have been requested by the parent, guardian, or custodian for the family when there are and provided to children and families who have no current allegations of child abuse, neglect, or dependency. as specified in rule 5101:2-1-01.1 of the Administrative Code.
- (11) For a required Required non-lead PCSA interview report, the PCSA shall follow the procedures pursuant to rules 5101:2-36-03, 5101:2-36-04, and 5101:2-36-09, and 5101:2-42-20 of the Administrative Code.

- (12) For a stranger <u>Stranger</u> danger investigation, the <u>PCSA</u> shall follow the <u>assessment/investigative procedures specified in pursuant to</u> rule 5101:2-36-05 of the Administrative Code.
- (13) For an unruly/delinquent <u>Unruly/delinquent</u> report, as specified in rule 5101:2-1-01 of the Administrative Code. the <u>The PCSA</u> shall complete an assessment to identify the need for services designed to promote child safety, permanency, and well-being for a child determined to be unruly or delinquent follow the procedures outlined in the county child abuse and neglect memorandum of understanding developed pursuant to rule 5101:2-33-26 of the Administrative Code.

(14) ICPC report, pursuant to rule 5101:2-52-04 of the Administrative Code.

- (B)(C) Completion of the JFS 01401 "Comprehensive Assessment and Planning Model -I.S., Safety Assessment" (rev. 2/2006) is optional required for all family in need of services, reports except for a stranger danger investigation investigations.
- (C) The JFS 01400 "Comprehensive Assessment and Planning Model I.S., Family Assessment" (rev. 2/2006) may be completed for family in need of services reports.
- (D) Except as provided in paragraph (E) of this rule, Completion completion of the JFS 01400 "Comprehensive Assessment and Planning Model - I.S., Family Assessment" (rev. 7/2006) is required for all family in need of services reports transferred for ongoing PCSA services prior to the completion of the case plan pursuant to rule 5101:2-38-01 or 5101:2-38-05 of the Administrative Code. except for the following:
  - (1) Deserted child.
  - (2) Emancipated youth.
  - (3) Permanent surrender.
- (E) The following family in need of services report subcategories do not require the completion of a JFS 01400 prior to the completion of the case plan:
  - (1) Deserted child.
  - (2) Emancipated youth.
  - (3) Permanent surrender.
  - (4) ICPC.

- (E) When a PCSA categorizes the information as an information and/or referral, the PCSA shall do one or more of the following:
  - (1) Direct or advise the individual to contact a non PCSA service provider within the county.
  - (2) Direct or advise the individual to contact a non-PCSA service provider outside the county.
  - (3) Provide information to the individual without directing the individual to another service provider.
  - (4) Document licensing violations that are not child abuse and/or neglect referrals.
  - (5) Document information that is not an allegation of abuse, neglect, dependency, or stranger danger as additional information on an open PCSA case.
- (F) The PCSA shall not take any action other than that specified in paragraph (E) of this rule for intakes categorized as information and/or referral.
