The presenting rule revisions were developed through the Child Protective Services Rule Review Team and approved by the Partnership For Ohio's Family Rule Coordination Board.

OAC rule 5101:2-36-11 entitled Justification to extend time frames for completion or waive completion of assessment/investigation activities outlines the process to extend the timeframe to complete assessment/investigation activities and outlines which assessment/investigation activities may be waived. The title has been revised to clarify the purpose of the rule. This rule has been amended to incorporate allowable extensions of assessment/investigative activities specific to Alternative Response and Traditional Response pathways. Criteria have been established addressing waiving a signature on a safety plan. Criteria have been established regarding waiving certain assessment/investigative activities if the report has been previously assessed or investigated. Grammatical changes, restructuring the order of paragraphs, and revisions to requirements for consistent understanding have occurred throughout the rule.
