This rule outlines the process to extend the time frame to complete assessment/investigation activities and which assessment/investigation activities may be waived.

This rule has been amended to incorporate an allowable extension for the following:

The written notification of the report disposition to the alleged perpetrator if the alleged perpetrator is the subject of a law enforcement investigation into human trafficking. The extended time frame shall not exceed 120 days from the date the Public Children Services Agency(PCSA) screened in the referral as a child abuse and/or neglect report.

Completion of a second attempt of face-to-face contact in order to complete the Safety Assessment within four working days from the screening decision when specific child focused safety criteria have been met and recorded.

The written notification of the report disposition to the alleged perpetrator if the alleged perpetrator is the subject of a law enforcement investigation into human trafficking. The extended time frame shall not exceed 120 days from the date the PCSA screened in the referral as a child abuse and/or neglect report.
