This rule has been amended to provide clarity to public children services agencies (PCSA) charged with the child protective services function. The rule revision is a product of the collaborative partnership between Ohio Department Job and Family Services and county Public Children Services Agencies. The presenting rule revisions were developed through the Child Protective Services Rule Review Team and approved by the Partnership For Ohio's Family Rule Coordination Board.

OAC 5101:2-36-12 entitled PCSA requirement for cross-referring reports of child abuse and/or neglect outlines the requirements of the PCSA to refer reports of child abuse and/or neglect to entities with a need for such information to carry out their respective duties. Grammatical changes, restructuring the order of paragraphs, and revisions to requirements for consistent understanding have occurred throughout the rule. The notification requirements of the superintendent of public instruction have been removed.
