This rule has been amended to provide clarity to public children services agencies (PCSA) charged with the child protective services function. The rule revision is a product of the collaborative partnership between Ohio Department Job and Family Services and county Public Children Services Agencies. The presenting rule revisions were developed through the Child Protective Services Rule Review Team and approved by the Partnership For Ohio's Family Rule Coordination Board. The comprehensive review has served as a five year rule review.

OAC rule 5101:2-37-02 entitled PCSA requirements for completing the safety plan sets forth the PCSA requirements in developing a safety plan for a child determined to be in immediate danger of serious harm. The requirements to implement a safety plan have been clarified. The requirements regarding obtaining signatures and monitoring a safety plan have been revised for clarity. Requirements addressing verbal authorizations, extension to obtain a signature, and waiving a signature have been included. Notification time frame requirement regarding the termination of a safety plan has been revised. Monitoring requirements have been clarified. Grammatical changes, restructuring the order of paragraphs, and consistency addressing the requirements and expectations have occurred throughout.
