This rule establishes the requirements for public children services agencies to complete a safety plan for families whose children are in danger of serious harm. This rule will be replacing rule 5101:2-34-37 for PCSAs that are implementing the Comprehensive Assessment and Planning Model - Interim Solution. It is substantially the same as the rule it is replacing. Language incorporating the use of the Comprehensive Assessment and Planning Model - Interim Solution tools has been incorporated throughout this rule. Other new requirements include parental authorization of the safety plan and monitoring the safety plan.
