This rule outlines the provisions that govern eligibility, the administration and application process for the KPI program. The rule allows the public children services agency (PCSA) to provide incentive payments to kinship caregivers to promote permanency. Changes to this rule were made to the dollar amount of the incentive payments in paragraph (D). Incentive payment amounts will now be issued every state fiscal year via a procedure letter.
