This rule outlines the policy on non-discrimination in the foster care placement process. It is replacing a rule of the same number. New requirements have been added for handling certain comments by persons living in the household of a family

who has expressed an interest in adopting a child. Licensed professionals conducting Individualized Child Assessments must now receive educational material about federal legislation regarding non-discrimination based upon race, color, or national origin in the foster care and adoptive placement process prior to conducting such assessments. Language has been added prohibiting intimidation or retaliation against any person who has filed any oral or written complaint, testified, assisted, or participated in any manner in the investigation of any alleged violation of federal statutes prohibiting discrimination based upon race, color, or national origin.
