This rule is being proposed for amendment to update and clarify the policies and practices relating to the administration of relative and nonrelative home assessments.

This rule sets forth the overall requirements of the Public Children Services Agency or Private Child Placing Agency having custody of a child to consider approving and placing a child with a relative or nonrelative if the placement is determined to be in the child's best interest. This rule was amended to clarify the criminal offense and rehabilitation guidelines precluding approval of a placement with a relative or nonrelative caregiver. The changes to the criminal offense section now mirror the foster care licensing rule through incorporation by reference.
