This rule is being proposed to replace 5101:2-42-18 to allow PCSAs and PCPAs to

make placements of children with relatives and nonrelative who do not choose to become licensed as foster homes. This new rule sets forth the requirements and gives more direction for minimum assessments which must be conducted to assure that the placement is safe and appropriate and that the relative or nonrelative has the ability and willingness to properly care for the child.
