6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

The rule is being filed to give former custodial agencies guidance in providing independent living services to former foster youth who emancipated from the agency's care due to attaining age 18. Provision of these services is a condition of the federal Chafee Foster Care Independence Act to receive any of the federal

Independent Living allocation.

The rule is new and contains guidance to assist public children services agencies in providing independent living services to youth who have emancipated from foster care. If the PCSA is going to provide these services, they must first explore other community resources and complete an evaluation of the services needed by the youth. A mutually agreed upon written plan must be developed for service provision. Up to 30% of a PCSAs IL allocation may be used for room and board for 18 - 21 year old youth who have emancipated from foster care.

This will increase expenditures

The funds are entirely federal. Because these are entirely new services, it is unknown how many youth will seek to participate. Therefore it is impossible to estimate the amount of the increased expenditures.

The department has in the past received \$2.8 million per year in federal independent living funds. Under the new federal Chafee Foster Care Independence Act, this will increase to about \$4.9 million per year.

Expenditure: The entire federal allocation is distributed to public children services agencies.
