This rule is being proposed for amendment as a result of Titles IV-B and IV-E of the Social Security Act known as the Patient Protection and Affordable Care Act.

This rule sets forth guidelines by which public children service agencies (PCSAs) and private child placing agencies (PCPAs) must follow when instructing youth emancipating from child welfare. The changes to the rule includes striking paragraph (J)to create a new paragraph (J). The new paragraph directs the inclusion in the transition plan of health insurance options and information to be provided to youth on obtaining a health care power of attorney and how to execute a power of attorney. The rule also includes the transition plan to inform youth on how to obtain a credit report, register for selective service, be made aware of any existing court fees in the youth's name and any existing benefits and how to apply for the continuation of those benefits. The rule also includes the coordination with other agencies to obtain the original birth certificate, social security card and a state identification card.
