This rule is being proposed for amendment to adhere to the five year rule review.

This rule sets forth the requirements for Public Children Services Agencies (PCSAs) and Private Child Placing Agencies (PCPAs) to prepare youth for the transition from agency custody to self-sufficiency. Changes include:

In paragraph (D)(3)(c) ", " was stricken.

In paragraph (D)(4)(b) ", " was added after "nursing".

In paragraph (N) "(L)" was stricken and replaced by "(M)."

In paragraph (D)(5)(b) "or" was added between "checking and savings."

In paragraph (D)(9) "being" was added before "matched."

In paragraph (D)(11) "The PCPSA or PCPA shall not use the Chafee allocation or TANF funds for room and board pursuant to rule 5101:9-6-35 of the Administrative Code for:" was added.

Paragraph (E) "(D)" was stricken and replaced with "(C)."

New Paragraph (H) was added with two sub-sections.

Paragraph (E) "A copy of the plan and any subsequent updates shall be provided to the youth and caregiver within thirty days of the development of the plan or the update as applicable." was added.

Paragraph (G) "child's attorney, GAL/CASA" was added in the list of contacts.

Paragraph (I)(1) "(E)" was stricken and replaced by "(D)."

Paragraph (J) "Ninety" was stricken and was replaced with a new time frame reference of "At least ninety."

Paragraph (K)(9) "and information on obtaining a drivers license." was added. This addition restructured the list following this addition.
