This rule is being amended for clarity and to include language from Public Law 113-183, that requires caseworkers to request a credit report from each of the three major credit reporting agencies each year until the child is discharged from substitute care.

This rule sets forth the requirements for Public Children Services Agencies (PCSAs) and Private Child Placing Agencies (PCPAs). Changes include language regarding when a child in custody is to receive a credit report and the frequency at which credit reports are to be requested. Minor revisions were made to correct errors in grammar.
