In paragraph (B) the first sentence reading "When placement of a child occurs on an emergency basis as set forth in rules 5101:2-39-01 and 5101:2-39-03 of the Administrative code, preplacement services listed in this rule may not be possible." was stricken.

A new sub section (5) has been added and reads: "Placement of a child on an emergency basis as set forth in rules 5101:2-39-01 and 5101:2-39-03 of the Administrative Code." was added.
