This rule is being proposed to enhance state policy standards regarding the safety of children in foster care placements. Five year rule review.

This rule requires interviews be completed within seven days of a foster child's exit from each foster care placement. The amendments relax the requirement that the interview be completed by only a caseworker. Section (E)(2) was also revised easing the exit interview requirement for placements of less than seventy-two hours, from the previous version of twenty-four hours.
