This rule sets forth the requirements for public children service agencies and private child placing agencies to share information about children in custody with caregivers, school districts and juvenile courts. It includes the information that must be provided in the individual child care agreement. This rule is being proposed to replace a rule of the same number. It is substantially the same as the rule it is replacing. It has been reorganized throughout for clarity and consistency and contains no new requirements.
