This rule sets forth the requirements of a public children service agency (PCSA) or private child placing agency (PCPA) for pursuing permanent custody and terminating parental rights. The phrase "At the time a motion is filed with the court to obtain permanent custody of the child" was deleted from paragraph (D).
