This rule is being proposed to consolidate the requirements of 5101:2-44-03, which it is replacing, and 5101:2-44-07.

This rule sets forth the administrative requirements for public children services

agencies (PCSAs) to administer the state adoption subsidy program. This rule is being proposed to replace a rule of the same number and to incorporate provisions previously contained in 5101:2-44-07 which is also being rescinded. This new rule is substantially the same as the two rules that it is replacing. The new rule has been reformatted for clarity and consistency with other programs and updates references to the titles of forms. It contains new requirements to assess the child's special need for the state adoption subsidy and the child's special need for medical, mental health, or rehabilitative care including the required agency procedures when the applicant is approved for a state adoption subsidy but the adoptive child does not have a special need for medical, mental health, or rehabilitative care.
