OAC rule 5101:2-44-5.2 entitled "Covered families and children (CFC) Medicaid Eligibility for State Adoption Subsidy Recipient Moving from or to Ohio" outlines the requirements of the PCSAs to process paperwork related to Medicaid eligibility for state adoption subsidy recipient moving from or to Ohio. It also details the adoptive parents' responsibilities to notify the PCSA of moves to another state. The phrase "telephone number" was replaced with the phrase "contact information" to comply with the CSI project to identify out of date Ohio Administrative Code methods of communication and ORC terms that require in-person interaction. The term "SACWIS" was changed to "Ohio SACWIS." The revisions dates for forms were removed throughout.
