The rule addresses the component of HB 95 which requires the elimination of the state adoption special services program effective July 1, 2004. The rule is also consistent with HB 95 in that the rule sets forth the eligibility requirements which must be met in order to continue all state adoption special services agreements entered into prior to July 1, 2004.

The tagline has been changed to "Requirements for the state adoption special services subsidy program" because the rule now addresses more than just the redetermination process. The rule provides further clarification and procedures for PCSAs electing to continue or discontinue the state adoption special services subsidies for those special services subsidies in effect prior to July 1, 2004.

Paragraph (A) clarifies as of July 1, 2004, new state adoption special services applications will not be approved. Paragraph (B)notifies the agency that the PCSA may, at its option, continue the state adoption services subsidy program for approvals in effect prior to July 1, 2004. Paragraph (C) mandates the agency to indicate in its adoption policy whether the agency will or will not continue providing the state adoption special services subsidy program for existing approvals. Paragraph (D) outlines the procedures for PCSAs electing to continue the state adoption special services subsidy program. Paragraph (E) outlines the procedures for PCSAs electing to discontinue the state adoption special services subsidy program. Paragraph (F) outlines under what circumstances the PCSA can suspend the state adoption special services subsidy. Paragraph (G) addresses hearing rights when the redetermination results in a decrease, suspension or termination of the state adoption special services subsidy.
