This rule sets forth the requirements for state adoption subsidy records maintained by a PCSA.

Paragraph (B)(4) emphasizes documentation needed to verify the child's special needs for a state adoption maintenance subsidy. Paragraph (B)(6) is stricken to remove the reference to state special services subsidy. Paragraph (B)(8) emphasizes the need for documentation to verify the child's special needs for medical, mental health, or rehabilitative care. Paragraph (B)(13) adds JFS 01616 "Social and Medical History" and removes "adoptive homestudy." Paragraph (B)(14) adds JFS 01673 "Assessment for Child Placement (Homestudy)." These changes clarify and update current practices and procedures
