This rule, Post Adoption Special Services Subsidy (PASSS) is a state funded program designed to assist eligible families, after adoption finalization.

The changes made are:

Definitions were given to "mentally handicapped," as a condition of mental retardation and/or mental illness; and "physically handicapped," as an impairment of vision, speech, or hearing; congenital orthopedic impairment, orthopedic impairment caused by disease, or orthopedic impairment from other causes (e.g., amputation); impairment caused by chronic or acute health problems (e.g., rheumatic fever); or a concomitant of the aforementioned.

Clarification was given to what type of vehicle modification and computer software PASSS would fund, "e.g. lift added to a van, car or transportation services" and to "software suggested by a qualified professional that will help or improve the mental and physical condition of the special needs child."
