This rule sets forth the requirement for the Title IV-E agency to make a referral to the Title IV-D agency. A referral is made when the Title IV-E agency receives legal responsibility for the care and placement of a child who is eligible for foster care maintenance. A referral may be made on behalf of noneligible children to the Title IV-D agency.

Paragraph (A) the timeframe for making the referral has changed from ten working days to thirty days. A sentence has been added to the paragraph regarding the assignment of child support to the Ohio Department of Job and Family Services. In paragraph (D) the word "absent" was deleted.

The rule had lengthy paragraphs that were changed to smaller paragraphs to add clarity.
