This rule is being amended for a five year rule review to update and include a referral and electronic process through a system interface with Title IV-D (Child Support) and Title IV-E (Foster Care Maintenance) to exchange pertinent data to

determine foster care maintenance (FCM) eligibility.

The rule outlines the Title IV-E (Foster Care Maintenance) referral process through the Statewide Automated Child Welfare System (SACWIS) with Title IV-D (Child Support) through the Support Enforcement Tracking System (SETS). The interface data sharing will send custody, inquiry, eligibility, absent parent, foster care maintenance (FCM) payments, demographic information, and child support and paternity information in order to: exchange information with SETS; meet Federal requirements documented in U.S. Department of Health & Human Services Administration for Children & Families (ACF), Information Memorandum (IM) ACYF-CB-IM-12-06 OCSE-IM-12-02; and redirect child support payments when a child is taken into IV-E agency custody. In addition, the rule includes the interface with Ohio Integrated Eligibility System (OIES) Medicaid and the SACWIS system to share required data information to determine FCM IV-E eligibility. The changes to the rule are as follows:

OAC 5101:2-47-08, entitled Required Application/Update for Title IV-D (Child Support) Services and Referrals to Title IV-A (Public Assistance); Healthchek; Third Party Insurance; and Supplemental Security Income (SSI). This rule outlines the responsibilities for the administration of the Title IV-E Foster Care Maintenance (FCM) program and the Title IV-D Child Support program. In paragraph (A)(1), language was added to require the Title IV-E agency to make child support referrals for Title IV-E eligible children through the statewide automated child welfare information system (SACWIS). The use of form JFS 01435 "Title IV-E Agency Application/Updates for Child Support Services" (rev. 4/2006) was removed from the rule as the form is now obsolete as well as form JFS 01435-I "Instructions for Completing the JFS 01435 Title IV-E Agency Application/Update for Child Support Services" (rev. 4/2006).

In paragraph (A)(2), form JFS 01435 "Title IV-E agency application/updates for child support services" (rev. 4/2006) was removed from the rule as the form is now obsolete. The words "of "and "referral" were added for clarification to the rule. And, deletion of "Title IV-E agency obtains legal responsibility for the care and placement of the child."

Paragraph (A)(2)(a), was changed for clarification when assignment of support is effective.

Paragraph (A)(2)(b), the sentence was changed for clarification when IV-E agencies terminate custody after child support rights have been assigned.

Paragraph (A)(2)(c), has been removed from the rule.

Paragraph (A)(3), removal of JFS 01435 "Title IV-E agency application/updates for child support services" (rev. 4/2006) as the form is now obsolete.

Paragraph (A)(4), has been removed from the rule.

Paragraph (A)(5)(a)(b)(c)(d), was added to include language for good cause circumstances for a child support referral.

Paragraph (B)(1), has been removed from the rule.

Paragraphs (B)(4) and (B)(5), were deleted and a new (B)(4) was added with new language to explain collection and disbursement of child support payments through child support payment central (CSPC).

Paragraph (C), was added to include language for the disbursement of child support payments to support the cost of care.

Paragraphs (C)(D)(E)(F), were changed to (D)(E)(F)(G) to reflect correct letter format within the rule.

Paragraph (D), was changed to extend the county notification in SACWIS from ten (10) business days to sixty (60) business days.

Paragraph (F), the revision date to form JFS 03528 "Healthchek and Pregnancy Related Services Information Sheet" (rev. 5/2011) was changed to (rev. 3/2014).

Paragraph (G)(1), the revision date to form JFS 06612 "Health Insurance Information Sheet" (rev. 6/2009) was changed to (rev. 5/2001).

Paragraph (G)(2), the revision date to form JFS 06613 "Accident/Injury Insurance Information Sheet" (rev. 7/2003) was changed to (rev. 6/2009).
