This rule sets forth case record requirements for Title IV-E Foster Care Maintenance program. Title IV-E agency is required to maintain a separate record for eligibility documentation. The specific requirements for determining eligibility which is detailed in division 2 in chapter 47 of the Administrative Code, is to be contained in a file outside of the child's case record. Included in the file is the eligibility determination documentation, court orders, placement log, foster care license(s), ADC related documentation and citizenship verification.

The rule has been amended regarding which documentation is acceptable as proof of citizenship. This language has been taken from the Tax Relief and Health Care Act of 2006 (TRHCA).
