This rule outlines the reimbursement criteria for children who are eligible for foster care maintenance. The revision date of the JFS 02911 "Title IV-E Single Cost Report" was changed to July, 2013. The use of the JFS 01925 "Monthly FCM Facility Invoice" for reimbursement was removed as all reimbursements are made through the statewide automated system.
