The rule outlines the requirements for initial eligibility and reimbursability. Effective April 1, 2010, a redetermination of continued eligibility is no longer

required. The rule 5101:2-47-21, "Foster Care Maintenance (FCM): Redetermination of Program Eligibility and Reimbursability" is being rescinded. Some of the language from that rule regarding the age criteria and when children are no longer eligible for reimbursement was added to this rule.
