This rule is being proposed for amendment as a result of the five year review.

This rule sets forth the legal responsibility requirements for the foster care maintenance program. The legal responsibility requirement for foster care

maintenance allows a child to enter care through a court order, a JFS 01645 "Agreement for Temporary Custody" or a JFS 01666 "Permanent Surrender of Child". The timeframe for obtaining a judicial determination to the effect that continuation in the home is contrary to the best interest of the child or that placement is in the best interest of the child was changed from 181 days to 180 days if the child enters care as the result of a JFS 01666 "Permanent Surrender of Child" to mirror federal requirements. New language has been added to this rule to clarify that affidavits, amendments and nunc pro tunc orders will not be accepted as verification documentation of these.
