This rule outlines the Aid to Dependent Children (ADC) program requirements for foster care maintenance. Paragraph (D) was revised to add language to address the FFPSA changes to the eligibility requirement of "living with a specified relative within the last six months" for a child who is a candidate for Family First Prevention Services (FFPS) and in the home of a kinship caregiver at the time of the removal and the removal is from the parents. Revisions included minor changes to language to add clarity.
