This proposed rule has been amended as part of a five year review.

This rule outlines the requirements for placement settings that are eligible for foster care maintenance reimbursement. In paragraph (A)(9), language was added to explain that an alternative care setting is a family foster home at the same level of care as the current foster home for a child temporarily placed into another family foster home for more than twenty-four hours, but for no more than fourteen days as long as the child returns to the original family foster home by the end of the fourteen days. Language was added to paragraph (B) to add clarity regarding reimbursement for payments made to hold a bed for a child on leave.
